# 3. Cancellation & Refund Policy

# By the Customer:

Cancellations made 14 days or more before the tour: 100% refund, minus admin fees. Cancellations made 3–13 days before the tour: 50% refund.

Cancellations made less than 48 hours before the tour: No refund.

# By the Company:

We reserve the right to cancel or reschedule a tour due to unforeseen circumstances (e.g. weather, insufficient participants, safety concerns).

If we cancel the tour, customers will be offered the choice of:

A full refund
An alternative date or tour

#### 4. Amendments to Bookings
